Campground Speed Limit

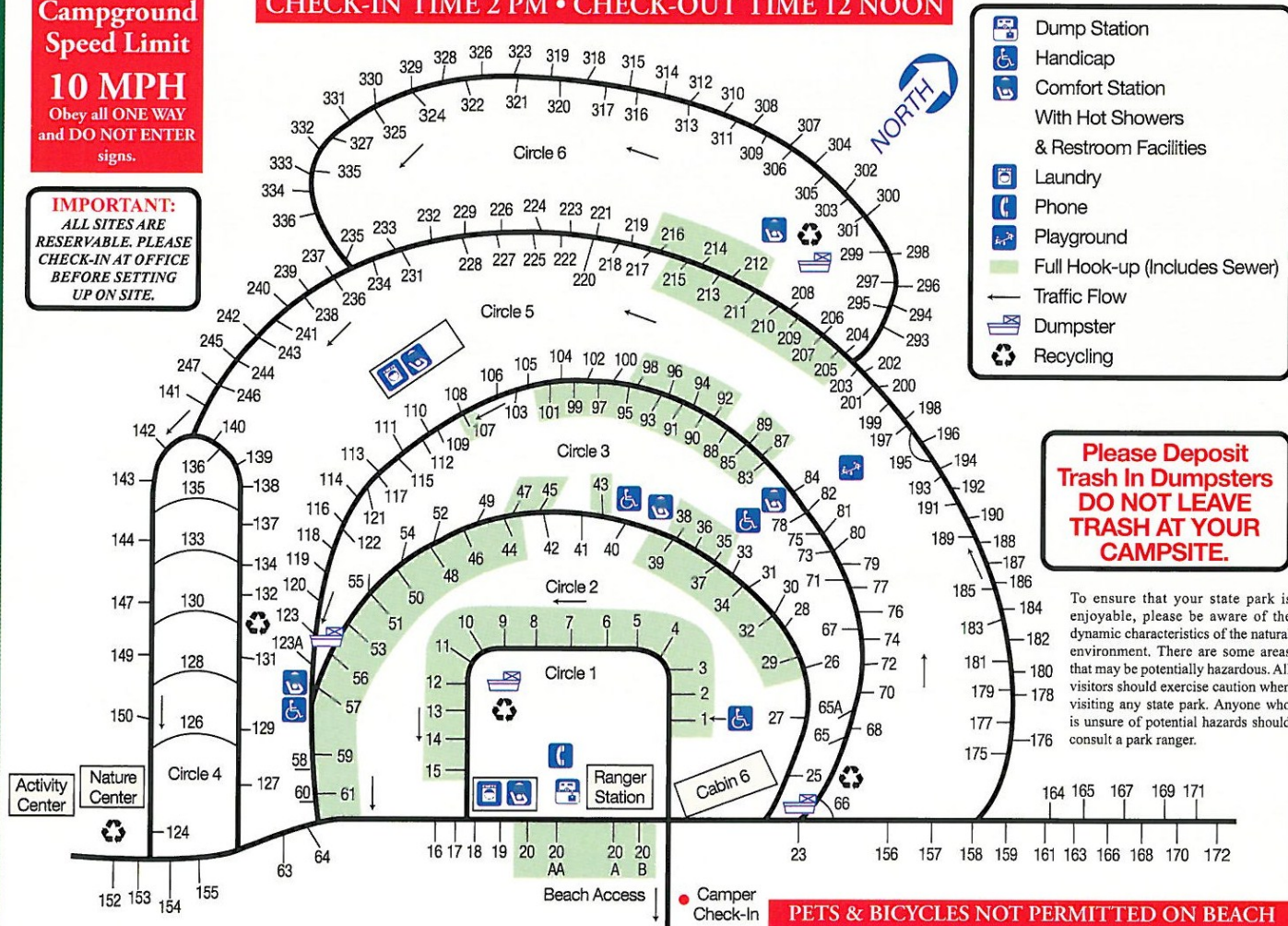

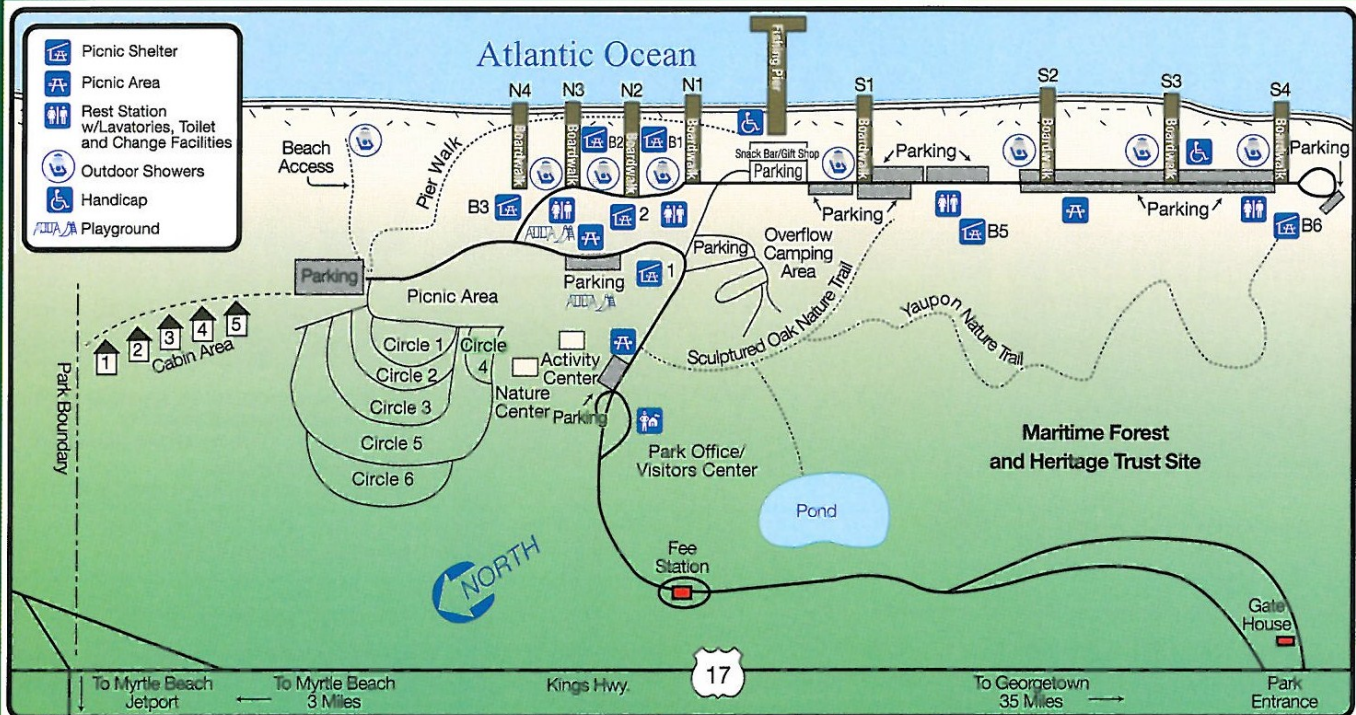

Campground Rules and Regulations

1. Campers are allowed a maximum of one trailer/RV and one tent OR two tents per site. No more than six (6) persons (or one family) may occupy the same site.
2. **Obey all one way and do not enter signs. Maximum speed limit is 10 MPH.**
3. Two sites designated for use by disabled persons are available.
4. Camping check-in is 2 PM; **check-out is 12 Noon.**
5. **Quiet hours are 10 PM - 7 AM.**
6. Maximum length-of-stay on a particular site during periods of high demand is 14 nights. Longer stays are allowed during periods of less demand.
7. **Bicycles, skateboards/scooters and golf carts are not permitted on any sidewalks around buildings, or allowed on the roads in the park between nightfall and daybreak.** Golf carts are not allowed on beach access roads. Bicycles are not allowed on the beach May 15 to September 15 between 8 AM and 5 PM.
8. **Alcoholic beverages are prohibited.**
9. Pets must be on a leash (not longer than six feet) or under physically restrictive control at all times. Owners will be asked to remove noisy or dangerous pets or pets that threaten or harass wildlife. Pets are not allowed in cabins or cabin areas. Pets are not allowed on the beach May 15 to September 15 between 8 AM and 5 PM. Please clean up after your pets.
10. **It is unlawful to dispose of any waste (including gray water) in places or receptacles other than those specifically designed for that purpose. Washing dishes in any restroom sink is strictly prohibited.**
11. All fires must be confined to designated fire rings/grills. **Please put out all fires prior to checking out.**
12. It is unlawful to cut, damage or remove plants, shrubs or trees.
13. **Possession of firearms is prohibited** except by certified park rangers and other authorized personnel.
14. It is unlawful to possess or discharge fireworks or other explosives. (This includes the beach.)
15. Only licensed vehicles may be operated in a state park and must remain in areas specifically intended for vehicular traffic. Golf carts must display a valid permit at all times and operator must have a valid drivers license and proof of insurance.
16. Cancellations and changes are subject to fees based on the notice given. Changes are not permitted unless requested at least four days in advance for camping. Early departures are subject to cancellation policies. Transaction fees and taxes are non-refundable.
17. Registered campers may not change sites without permission from park staff.
18. **South Carolina senior citizens** (age 65 and older) and disabled residents may register for a campsite at a reduced rate. The qualifying individual must be present for the duration of the stay.
19. **Visitors not registered for an overnight stay are required to pay the admission fee.**
20. Roadside parking is prohibited. Do not park on unoccupied sites for any length of time.
